RISING SUN SOBER LIVING HOUSE RULES

1. Absolutely no alcohol and/or drugs on or off the premises while in housing.
2. Overnight passes are allowed. Guests on probation/parole need permission from PO.
3. Must sign-in and sign-out on the house Accountability Board.
4. Nightly Curfew is 10:00pm. Exceptions are made for work schedules and special circumstances.
5. Curfew violators will be required to pass a drug test upon return. Test fee is \$20.
6. Agree to random drug/alcohol testing.
7. If unwilling or unable to produce a sample for drug testing, I agree to leave premises immediately and will not return until a negative test result can be provided.
8. Agree to random searches of personal property.
9. Rising Sun is not responsible for loss, damage or stolen property. Lock boxes are recommended.
10. A \$20 fee will be charged if Rising Sun has to pack & store personal belongings. I understand my belongings will be donated after 30 days.
11. All common areas in housing are treated with respect, cleanliness, consideration and sharing.
12. No personal refrigerators, microwaves, coffee pots, heaters, furniture, candles or excessive property allowed.
13. Any resident caught stealing will be immediately discharged from housing.
14. We have an open-door policy with Law Enforcement, Probation/Parole, and Court Service Programs. All residents agree to be respectful to all.
15. Smoking is allowed outside only in designated smoking areas. Anyone caught smoking inside will be discharged.
16. No visitors are allowed on Rising Sun property to insure all are Safe, Clean and Sober.
17. Verbal or physical violence towards another resident or staff will result in discharge.
18. Agree to do daily chore, make bed, and pick up their personal area before leaving each day.
19. No borrowing of money from other residents or staff.
20. There is no continual borrowing of cigarettes, food or clothing from others. Health & Welfare will provide emergency food stamp card with picture ID. St. Vincent de Paul 208-331-2208 will provide clothing vouchers, bus passes and bikes when funds are available.
21. No romantic/intimate relationships with other residents.
22. Must be kind and considerate when speaking to other residents and staff.
23. Agree to work a program of recovery while in housing. Rising Sun highly recommends attending 12 Step meetings or other community recovery program such as Celebrate Recovery.
24. No pets of any kind are allowed in housing.
25. Must be friendly and courteous to neighbors.
26. Narcotics and controlled substances are not allowed. We practice TOTAL ABSTINENCE from all mind-altering substances, legal or illegal including spice, Kratom, bath salts and designer drugs.
27. Medication-Assisted Treatment programs are allowed.
28. Suspicion of drugs/alcohol use by another resident should be reported immediately (24/7) to House Manager, Director 208-995-0735 or Main Office 208-898-4668. You will remain Anonymous and we will remove anyone who is unable to pass drug/alcohol test.
29. Supplies are delivered weekly. Items delivered are a privilege and not part of the housing fee.
30. Internet, Cable TV and Phone services are provided at each location. Any abuse of data usage or calls made to 411 information will cause an interruption in services.
31. Vehicles must be in good working order and registered. Only one vehicle per resident. There is no maintenance of vehicles allowed on or around property, under any circumstances.
32. Housing Costs, House Rules and Clients Rights are posted in all houses.
33. Housing Fee: \$425/Monthly, \$225/Bi-Weekly, \$125/Weekly. Residents who pay early or on-time receive a \$25 discount. All other payments must be made at standard rate. No Exceptions.
34. It is the responsibility of the resident to know when his/her rent is due and should be placed in rent box. We do not accept cash payments. Please pay with money order or on-line at website.
35. Rising Sun is an approved BPA housing provider. For eligibility call 1-800-922-3406. If you are approved for housing call our main office at 208-898-4668 to verify we have received Authorization. BPA Clients pay \$60/monthly program fee for utilities.
36. If Rising Sun House Rules or Policies are violated, you agree to whatever consequence deemed necessary by Staff ranging from 24-Hour *Standout to Discharge. (*Standout - A specified number of days when a resident is banned from the house.)
37. There are no required lengths of stay beyond the first month.
